Take NC 45 N. Turn right onto US Hwy 17 N.
 Continue on US-17 N for 32.5 miles. Take Exit
 255, Elizabeth City/US 17N. Travel 3.7 miles.
 Pass Jeffrey’s Florist. Fountain of Life will be on
 the right.

FROM THE WEST (AHOSKIE)

Take US Hwy 13 S.US-13 N. Continue to follow
 US-13 N. Turn slight right onto US-158 E. Turn
 right onto US-17 S/US-158 E. Stay straight to go
 onto US-17 By-Pass S. Take Exit 258, Halstead
 Blvd, toward NC-344. Turn left onto NC-334/
 Halstead Boulevard Ext. Turn right onto US Hwy
 17 S/US-17. Fountain of Life will be on the left.

FROM THE EAST (DARE)

Start out going North on Caratoke Hwy/US-158
 W. Turn left onto Shortcut Rd/US -158 W. Turn
 left onto US -158 E/US-158 W/NC-34. Continue
 to follow US-158 W. Turn left onto N Hughes
 Blvd/US-17 S. Continue to follow US-17 S for 2.5
 miles. Fountain of Life will be on the left.
